EXPLANATORY NOTES

- A) The Applicant may be one of the following;
 - i) the ship's owner; or
 - ii) the ship's manager; or
 - iii) any other person specifically authorised in writing by the ship's owner
 - B) If the applicant is a company, the name and status in the company of the person signing this application form must be stated
 - C) For "Type of Ship" to indicate in accordance with classification certificate
 - D) Indicate the ship's Official Number and IMO Identification Number
 - E) Indicate the ship's tonnage. The ship's tonnage shall be the gross tonnage calculated in accordance with the tonnage measurement regulations contained in Annex I of the International Convention on Tonnage Measurement of Ships, 1969
 - F) Indicate whether insurance contract, P & I cover, Bank Guarantee, Compensation Fund certificate, etc. If security is furnished in several forms, these should be enumerated.
 - G) The period of validity of the security must be stated in terms of its exact dates of commencement and cessation and must coincide with the dates given in the insurer's or guarantor's etc certificate.
 - H) Name (s) and address (es) of insurer (s) and / or guarantor (s) etc providing the security must be listed here. If the total amount of security has been furnished by more than one source, the amount of each of them should be indicated.
- Note: The fee for the issue of a certificate is S\$60.
