### <u>Details</u>

All barges will require a safe working zone of 30 meters radius centered at the barges. Shifting of barges will be assisted with 2 tugboats.

A safety boat will be deployed to warn other craft in the vicinity of the working area.

- e) Communicate with Sinki Control on VHF Channel 68 for assistance, if required.
