Jack-up Barge

These craft will exhibit the appropriate local and international day and night signals.

<u>Details</u> : The soil investigation work will be carried out by jack up barges assisted by tug boats. The safety zone is a circular area of 30m radius centered at the jack up barges.

A safety boat will be deployed to warn other craft to keep clear of the area during working hours.


