**SJC2 Submarine Cable System Seaward Duct Installation Works at Changi Landing**

Details : A work barge accompanied by a tugboat, will be deployed to perform the works. All vessels are required to keep clear by at least 300m from the work barges operating in the area.

A safety boat will be in attendance all times to warn passing craft to keep clear of the working area.
