UNDERWATER DRILLING AND BLASTING WORKS AT TEMASEK FAIRWAY

These craft will exhibit the appropriate local and international day and night signals.

Details : The underwater drilling & blasting works will be carried out by working and explosive barges supported by safety tugboats and workboats.

Blasting will be carried out on specific hours from Monday to Saturday. No blasting will be carried out on Sundays or public holidays unless prior approval has been received.

Blasting works will take place at the following timings:

- a. 0800hrs – 1000hrs
- b. 1200hrs – 1400hrs
- c. 1700hrs – 1830hrs

Safety boats will be in attendance to warn and direct craft in the vicinity to keep clear of working area.

- d) **Maintain a listening watch on VHF Channel 22 (Jurong Control);**

- e) **Communicate with Jurong Control for assistance, if required.**
