**FLIGHT TRIALS FOR AIRFISH WITHIN SINGAPORE PORT LIMITS OFF FRONTIER
BEACON**

Applicable to: Mariners operating in the vicinity Off Frontier Beacon

Date : With effect from 13 Nov 2025 to 14 Nov 2025.

Craft: Please refer to ANNEX A for the list of craft approved for deployment in the flight trial area.

These craft will exhibit the appropriate local and international day and night signals

Details : Air Fish Voyager (AFV) will depart Tanah Merah Ferry Terminal under tow by support boat to Work Area 2 – off Frontier Beacon.

AFV will conduct take-off, landing and manoeuvring trials over several runs within the trial site. Support boats will be responsible for ensuring the craft does not drift upon landing and as well as to reposition at the end of each run to the identified starting point upon arrival.

Once the trial is complete for each day, AFV will be towed back to Tanah Merah Ferry Terminal to berth at the floating pontoon.
