erection and dismantling of temporary working platform.

Notices, signs and barricades will be put up to notify public that works are in progress. Public and craft will be re-directed during movement of equipment in

the vicinity to keep clear of working area.

: When in the vicinity of the working area, mariners are reminded to:

- a) Keep well clear and not to enter the working area;
- b) Maintain a proper lookout;
- c) Proceed at a safe speed and navigate with caution.
- d) Maintain a listening watch on VHF Channel 12 (East Control) and VHF Channel 68 (West Control) when passing Lazarus Island and Pulau Hantu respectively; and
- e) Communicate with East Control on VHF Channel 12 & West Control on VHF Channel 68 for assistance, as required.
