BULK CARRIER OPERATIONS AT TUAS TERMINAL PHASE 2 PROJECT AREA

Applicable to: Mariners operating off Temasek Fairway and in the vicinity of Tuas Terminal

This PMN supersedes Port Marine Notice No. 77 of 2025. The working period has been extended, the chartlet and list of craft has been revised.

Date : With effect from 20 Dec 2025 to 19 Jun 2026.

Details

: During this period, bulk carriers, self-propelled barges and pusher tugs with barges in composite unit carrying sand will be transiting the Temasek Fairway to the Tuas Terminal Phase 2 Finger 3 reclamation project area.

A safety tug will be in attendance at all times to warn and re-direct craft in the vicinity to keep clear of working area.
