REINSTATEMENT WORKS AT ASTER SINGLE BUOY MOORING (SBM)

Applicable to: Mariners operating in the vicinity of Aster Single Buoy Mooring (SBM)

<u>Date</u>: With effect from 05 Jan 2026 to 28 Feb 2026.

<u>Location</u>: At sea, within the working area bounded by the following

co-ordinates (see attached chartlet):

Working area radius is 675m from center of point 1.

Working Hours : 24 hours daily, including Sundays and public holidays.

These crafts will exhibit the appropriate local and international day and

night signals.

<u>Details</u>

The SBM Reinstatement works will involve mooring chain installation, SBM connection, ROV and Diving works.

There will be up to six (6) vessels operating within the SBM 800m exclusion zone area.

Diving work will take place at various locations within the work area, primarily at the SBM Buoy location: 1° 11.463" N, 103° 47.427" E.

Safety boats will attend all times to warn and direct craft in the vicinity to keep clear of working area.
