FLUSHING WORKS AT SINGLE BUOY MOORING FOR PIPELINE PRESERVATION

Applicable to: Mariners operating in the vicinity of Aster Single Buoy Mooring (SBM), SW of Sebarok Island

Date : With effect from 24th Aug 2025 to 31st Aug 2025.

Location : At Sea, at points indicated by the following co-ordinates (see attached chartlet):

Working Area A (WGS 84 Datum)

<u>Point</u>	<u>Latitude (N)</u>	<u>Longitude (E)</u>
1	01° 11.463" N	103° 47.427"E

Working Hours : 24 hours daily including Sundays and Public Holidays.

Craft: Please refer to **ANNEX A** for the list of craft approved for deployment in the working area.

These craft will exhibit the appropriate local and international day and night signals.

Details : The scope of work includes pipeline flushing & preservation activities on the 48" SBM pipeline from the Pipeline End Manifold (PLEM) of the SBM offloading system.

There will be vessel anchoring activities and diving within the work area at SBM Buoy location. A 6 Point anchor barge will be deploying anchors at SBM work area. Surface anchor buoys will mark the locations of the anchors. Support tugs will assist anchor barge in deploying anchors.

Safety boats will attend all times to warn and direct craft in the vicinity to keep clear of working area.
