**DIRECT BERTHING AND UNBERTHING OPERATIONS, TUAS TERMINAL PHASE 2**

**Applicable to:** Mariners operating in the vicinity off Tuas Terminal

This is a revision of Port Marine Notice NO. 97 of 2024. The working period has been extended and the chartlet has been revised.

Date : With effect from 16 May 2025 to 16 November 2025.

Location : At Tuas Terminal Phase 2 project area, within the working area bounded by the following co-ordinates (see attached chartlet):

Craft : Please refer to **ANNEX A** for the list of craft for deployment in the working area.

These craft will exhibit the appropriate local and international day and night signals.

Details : During this period, bulk carriers, carrying sand in bulk will be transiting the Temasek Fairway to the Tuas Terminal Phase 2 Finger 3 Direct Discharging Berth.

A safety tug will be present at all times to warn and re-direct craft in the vicinity to keep clear of working area.
