### RELOCATION OF JETTY AT MARITIME SQUARE

Working Hours : 24 hours daily, including Sundays and public holidays.

Craft: Please refer to **ANNEX A** for the list of craft for deployment in the working area.

These craft will exhibit the appropriate local and international day and night signals

Details : Relocation of existing ferry piers and underpinning works in the working areas will be carried out using work barges assisted by tugboats.

All barges in the working area will require a safe working zone of 30 meters radius centered at the barge.

A safety boat will be in attendance at all times to warn and direct craft in the vicinity to keep clear of working area.
