Working Hours : 0700 – 2000 hours (Monday to Saturday). Working hours may differ subject to site circumstances.

Craft : Please refer to **ANNEX A** for the list of craft for deployment in the working area.

These craft will exhibit the appropriate local and international day and night signals.

Details : The installation of the marine facility for AirFish berthing at Tanah Merah Ferry Terminal will be carried out using primarily marina floats and workboats. Tugboats and workboats will be deployed to assist with the positioning of the crane barge, should the need arise for crane barge during the works.

A safety boat will be always deployed in the vicinity and in attendance to warn and re-direct crafts to keep clear of working area.
