SUBMARINE CABLE SYSTEM SEAWARD DUCT INSTALLATION WORKS AT CHANGI LANDING POINT

Applicable to: Mariners operating off East Johor Strait in vicinity of SAF Changi Ferry Terminal

This PMN supersedes Port Marine Notice No. 89 of 2025. The working period has been extended, and the list of crafts has been revised.

Date : With effect from 06 Jan 2026 to 05 Jul 2026.

Location : At sea in East Johor Straits, at points indicated by the following co-ordinates (see attached chartlet):

Craft: Please refer to **ANNEX A** for the list of craft approved for deployment in the working area.

These craft will exhibit the appropriate local and international day and night signals.

Details : A work barge and a flat top barge accompanied by a tugboat/safety boat, will be deployed to perform the works.

Work involves include shoring, seabed trenching, and installation of HDPE/STEEL pipes work.

The safety boat will be on standby at all times to alert and guide passing crafts/vessels to keep clear of the designated working zone.
