### MARINE CONSTRUCTION WORK AT TANJONG KLING

**Applicable to:** Mariners operating in the vicinity of Tanjong Kling

This PMN supersedes Port Marine Notice No. 131 of 2025. The working period has been extended and the chartlet has been revised.

Date : With effect from 08 Jan 2026 to 07 Jul 2026.

Details : The reinstatement works on foreshore structures and the seabed involves dredging activities, the transport and discharge of dredged material using various types of marine vessels, removal of cofferdam and sand pumping.

A safety boat will be deployed to warn other craft in the vicinity of the working area.
