#### **SALVAGE WORKS FOR DREDGER OFF TUAS WEST COAST**

**Applicable to:** Mariners operating in the vicinity off Tuas West Coast

Date : With effect from 24 Jan 2026 to 07 Feb 2026.

Craft: Please refer to **ANNEX A** for the list of crafts approved for deployment in the exercise area.

These crafts will exhibit the appropriate local and international day and night signals.

Details : Salvage operations will be carried out in the working area by the crane barge, held in place by 4 anchors. All vessels are requested to keep a minimum safety distance of 50m from the working area.

Safety boat will be deployed in the area to warn traffic in the vicinity.
