TESTING OF UNMANNED UNDERWATER VEHICLE (UUV) AND UNMANNED SURFACE VEHICLE (USV) AT SOUTHERN ISLANDS

Applicable to: Mariners operating in the vicinity off the Southern Islands from Seringat Beacon in East Keppel Fairway to the South of P Sakijang Bendera Islands

Date : With effect from 24 to 25 Feb, 02 Mar and 04 Mar 2026.

Location : At sea, within the trial area bounded by the following coordinates (see attached chartlet):

These crafts will exhibit the appropriate local and international day and night signals.

Details : The UUV/ USV will be deployed into the water via the aft deployment platform of Helios S1 (workboat).

The UUV and USV will be side towed back to be recovered by the workboat for subsequent trial runs.

Safety boats will be deployed to warn other craft to keep clear of the area during working hours.
