**REVISED NEA PORT HEALTH OFFICE OPERATIONAL HOURS**

1. Please be informed that with effect from **01 June 2026**:
  - a. The NEA Port Health office's operational hours will be revised from 24-hours daily to **7.00am – 10.00pm daily**, inclusive of weekends and Public Holidays.
  - b. Any emails sent to [Port Health\\_CRO@nea.gov.sg](mailto:Port_Health_CRO@nea.gov.sg) will only be processed during these revised operational hours.
  - c. Arriving vessels that meet the existing MDH requirements specified in Port Marine Circular No. 03 of 2026 (February 2026) are required to submit the MDH, along with the listed documents, at least **24 hours before arrival** at the Port of Singapore.
2. The implementation of these revised operational hours is necessary to optimise the allocation of resources during high-demand periods, thereby enhancing overall operational efficiency and service quality standards. It will be applicable to all services provided under the NEA Port Health Office
3. Inspection of ships at the anchorage will continue to be conducted daily, including weekends and public holidays, between 9am and 5pm. Inspection of ships docked alongside shore (port terminals and shipyards) will continue to be conducted every weekday between 9am and 5pm excluding weekends and public holidays.
4. All ship's masters or agent must ensure that ship sanitation certificates are collected during the revised operational hours from 01 June 2026.
