DEMOLITION OF FORMER PAXOCEAN SHIPYARD AT TUAS BAY

Applicable to: Mariners operating in the vicinity of PaxOcean Shipyard

This PMN supersedes Port Marine Notice No. 118 of 2025. The working period has been extended, and the chartlet has been revised.

Date : With effect from 20 Apr 2026 to 19 Oct 2026.

Craft : Please refer to **ANNEX A** for the list of craft approved for deployment in the working area.

These craft will exhibit the appropriate local and international day and night signals.

Details : The demolition of the existing shipyard, PaxOcean Singapore, at 33 Tuas Crescent will be carried out using primarily crane barge and flat top barge. Workboats and tugboats will be deployed to assist with the positioning of the crane barge and flat top material barge.

A safety boat will be deployed in the vicinity and in attendance at all times to warn and redirect craft to keep clear of working area.

- e) **Communicate with Jurong Control for assistance, if required.**
