This notice supersedes Port Marine Circular No. 6 of 2006.

2 With effect from 1 December 2010, pleasure craft with the prefix "SZH" will be permitted to be hired out or to be engaged in commercial chartering activities.

3 "SZH" pleasure craft will be required to comply with additional safety requirements such as vessel's stability criteria and hull/ structural integrity. The pre-licensing, annual and bi-annual inspections for SZH pleasure craft shall be carried out by a recognised surveyor approved by MPA. Please refer to Annex 1 for the list of recognised surveyors.

4 The dues payable for "SZH" pleasure craft has been reviewed to align them with the passenger carrying capacity of the craft. The following table shows the new dues payable for SZH pleasure craft.

<b>Passenger Carrying Capacity</b>	<b>New Dues Payable</b>
< 12 passengers	\$27 per 10 GT
> 12 passengers up to 20 passengers	Minimum of \$1,200
> 20 passengers	\$60 per passenger

5 The dues payable for "SZ" pleasure craft remain unchanged.
