**MANDATORY MARITIME COURSES FOR PORT LIMIT VESSELS CONDUCTED  
BY TRAINING SERVICE PROVIDERS**

1 Under the Maritime and Port Authority of Singapore (Harbour Craft Manning Licence Examination) Regulations, officers or persons seeking to work on board certain categories of ships in the port are required to attend relevant maritime courses recognised by the Port Master e.g. pilotage exemption courses for officers employed by the owners to navigate ships when moving in the port without the need to engage pilots.

2 MPA has appointed three training service providers (TSPs), namely STET Maritime Pte Ltd (STET), Sirius Training Education Institute (STeI) and the consortium of Wavelink Maritime Institute Pte Ltd and Singapore Maritime Academy (WMI-SMA) to conduct the mandatory maritime courses as shown in the Appendix 1.

3 MPA will continue to conduct most of the assessments at the Integrated Simulation Centre (ISC) to ensure the quality the courses conducted by the training service providers. The address of ISC is as follows:
