### MARITIME CLUSTER FUND SUPPORT FOR REVALIDATION OF CERTIFICATE OF COMPETENCY

- 1. This circular refers to MPA Shipping Circular No. 10 of 2014, dated 25 June 2014, to advise holders of Singapore-issued certificates of competency (CoCs) of the need to revalidate their CoCs to meet the requirements of the 2010 Manila amendments to the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers (STCW2010) and to be able to serve on board a ship.
- 2. CoCs issued by Singapore in compliance with the 1995 amendments to the STCW are valid up to 31 December 2016. Holders of existing Singapore-issued CoCs are required to take up additional courses in order to comply with the competency requirements of the 2010 Manila amendments to the STCW, and are advised to refer to Shipping Circular No. 10 of 2014 for the details of additional training required.

#### **Maritime Cluster Fund Support**

- 3. To minimise the financial burden resulting from the revalidation exercise, MPA will be providing Maritime Cluster Fund Manpower Development (MCF-MD) cofunding support for local seafarers (Singapore Citizens and Singapore Permanent Residents) to attend appropriate STCW courses required to revalidate their Singapore-issued CoCs.
- 4. The general guidelines of MCF-MD support are as follows:

- a. <u>Eligibility</u>: All Singapore Citizens and Singapore Permanent Residents on self-sponsorship or company-sponsorship holding Singapore-issued CoCs;
- b. <u>Validity of scheme</u>: Covers
  - i. All revalidation courses conducted and completed by 31 December 2016; and
  - ii. Retrospective funding support for locals who have completed the CoC revalidation courses from 25 June 2014 onwards:
- c. <u>Supportable courses</u>: List of mandatory CoC revalidation course types approved by MPA and as listed in Shipping Circular No. 10 of 2014; and performed in Training institutes, in Singapore;
- d. <u>Co-funding level from MCF-MD</u>: 70% co-funding support of qualifying course fees.
- 5. Please refer to **Annex A** for instructions to seek MCF-MD support for the revalidation of CoCs.

### <u>Section A</u>: For maritime companies interested to sponsor their employees to attend CoC revalidation courses from 1 October 2015

- 1. Decide on the CoC revalidation courses from the list of approved course providers;
- Complete and submit the "MCF Application Form for CoC Revalidation Courses – For use by company / union" to the selected course provider [Form is available on MPA's website at www.mpa.gov.sg];
- 3. Course providers will submit MCF Claim Form, on behalf of sponsoring maritime companies, to MPA to seek reimbursement of course fees;
- 4. MPA to verify and process claims;
- 5. Once verified, MPA will disburse 70% of course fees (excluding GST) back to course providers;
- 6. Course providers will reimburse companies accordingly.

## <u>Section B</u>: For maritime companies which sponsored their employees to attend CoC revalidation courses from 25 June 2014 to 30 September 2015, and wish to apply for MCF co-funding

- Complete and submit the "MCF Claim Form for CoC Revalidation Courses

   For use by company / union" to MPA directly. [Form is available on MPA's website at www.mpa.gov.sg];
- MPA to verify and process claims;
- 3. Once verified, MPA will disburse 70% of course fees, excluding GST, back to the companies directly.

# <u>Section C</u>: For maritime companies who have sponsored their employees to attend CoC revalidation courses from 25 June 2014 and 30 September 2015, and have received MCF funding

 No action is required as these companies have benefitted from MCF cofunding (i.e. 70% of course fees, excluding GST), which is similar to the new MCF Support for CoC revalidation.

### <u>Section D</u>: For individuals, on company-sponsorship, who are attending CoC revalidation courses from 1 October 2015

- Advise your company to refer to the instructions under Section A;
- No action required on your part

### <u>Section E</u>: For individuals, on self-sponsorship, who are attending CoC revalidation courses from 1 October 2015

- 1. Proceed to attend the CoC revalidation course conducted by any of the approved course providers;
- 2. Complete and submit the "MCF Claim Form for CoC Revalidation Courses For use by individuals" to MPA directly. [Form is available on MPA's website at www.mpa.gov.sq];
- 3. MPA to verify and process claims;
- 4. Once verified, MPA will disburse 70% of course fees (excluding GST) back to individuals directly.

### <u>Section F</u>: For individuals, on self-sponsorship, who have attended CoC revalidation courses from 25 June 2014 to 30 September 2015.

- Complete and submit the "MCF Claim Form for CoC Revalidation Courses

   For use by individuals" to MPA directly. [Form is available on MPA's website at www.mpa.gov.sq];
- 2. MPA to verify and process claims;
- 3. Once verified, MPA will disburse 70% of course fees (excluding GST) back to individuals directly.
