The New York Produce Exchange Form (NYPE) is the most widely used standard time charter party in the dry cargo sector of the industry. The revised NYPE was launched on 15 October 2015, the first revision since 1993. This revision is the first international shipping form that brings about the collaboration of the copyright holder, Association of Ship Brokers and Agents (ASBA), BIMCO and Singapore Maritime Foundation (SMF).

This event is the third global roadshow to introduce the newly published NYPE 2015 time charter party. Members of the NYPE 2015 drafting team would give their views on the key clauses and explain the benefits to users of adopting the new contract. There would also be a panel session for all participants.
