

**Conditions of Participation  
Maritime Cluster Fund (MCF)  
Talent@MaritimeSingapore - Industry Attachment (MCF-IA)**

By submitting this Application Form to the Maritime and Port Authority of Singapore (“MPA”), we hereby declare, acknowledge and agree that:

1. We have read and understand all eligibility requirements and conditions applicable to the MCF-IA available at <https://www.mpa.gov.sg/maritime-singapore/what-maritime-singapore-offers/developing-manpower/talent@maritimesingapore>
2. We confirm that all claims made by us on behalf of the students via this Application Form satisfy all such eligibility requirements at the time of submission and we undertake to promptly notify MPA in writing of any change in circumstances that may affect any eligibility;
3. All information furnished by us with this Application Form and all supporting documents submitted herewith are to the best of our knowledge and belief, true, complete and accurate and not misleading;
4. We confirm that our officers involved do not have any conflict of interest in the preparation, processing and submission of this Application Form and supporting documents;
5. We undertake to disburse the correct quantum of MCF Funding received to each respective student within 3 months of the date of receipt of the MCF Funding from MPA;
6. We have the necessary consents and authorisations from all individual(s) and organisation(s), whose personal data/information are disclosed as part of this Application Form and all supporting documents, to allow MPA to collect, use and disclose such personal data/information for the purposes of assessing and processing this Application Form, enabling MPA to improve on and perform its functions and duties under the Maritime and Port Authority of Singapore Act 1996 and other written law, and disclosing such personal data/information to any Ministry, Department, Agency, administrative or statutory body or corporation under the control of the Government of Singapore in compliance with MPA’s internal reporting and approval requirements and to any other entities which are under common control with it, or which are controlled by it;
7. At MPA’s request, we undertake to immediately return any excess or unutilised MCF Funding disbursed to us, in the event (a) of any erroneous disbursement in excess of the MCF Funding awarded; or (b) any MCF Funding were not disbursed to our students in accordance with these Conditions of Participation;

8. We understand that the utilisation of MCF Funding is subject to audit checks by MPA and such external auditors as it may appoint (“**Agents**”) from time to time, to ensure that the terms of the MCF Funding are being or were met and that all information submitted to MPA is accurate, correct and not misleading, and there is no misuse of the MCF Funding disbursed to us;
9. We undertake to keep all documentation relating to this MCF Funding for a period of 3 years from completion of the industry attachment, and to grant MPA and its Agents full access to all accounts, records, documents and assets in connection with the MCF Funding, and shall provide MPA and its Agents with all reasonable cooperation and assistance in connection with the audits; and
10. We acknowledge that it is an offence to furnish false or misleading information to MPA. In the event that we are found to have (a) misused any part of the MCF Funding or (b) suppressed any material information or made any material misrepresentation to MPA in connection with the MCF Funding, MPA shall be entitled to issue a notice requiring us to, in accordance with MPA’s instructions set out in such notice: (i) return to MPA the MCF Funding disbursed (or any part of it); and (ii) reimburse MPA all reasonable costs and expenses incurred by MPA and/or its Agents in connection with the audit. We shall, upon receipt of MPA’s notice, forthwith comply with MPA’s instructions set out in such notice. In addition, and without prejudice to such other rights and remedies as MPA may have at law, MPA shall be entitled to revoke any approval for MCF Funding granted in respect of any one or more of the students, and to withhold or terminate the disbursement of any further grants to us under the MCF-IA.
