## **Eligibility Criteria:**

## Important notes on eligibility and funding criteria:

- 1. Approvals of training grants are granted at MPA's sole discretion.
- The Training Grant shall be disbursed to the Training Service Provider only if the course attendee has met the following eligibility criteria:
  - i. The training grant is to be used only towards payment of course fees for MCF-approved courses and for no other purposes (including but not limited to payment for any event management, advertising, or sponsorship fees).   - ii. This form, duly completed and signed, must be submitted to the Training Service Provider of the MCF-approved course ("Training Service Provider") BEFORE the commencement of the course.
  - iii. Course attendees must be Singaporean Citizens or Singapore Permanent Residents;
  - iv. Course attendees may be self-sponsored ("Self-Sponsors") or employees of sponsoring business entities registered or incorporated in Singapore ("Corporate Sponsors");
  - v. Course attendees who are Public Officers must be self-sponsored;
  - vi. Course attendees must not be receiving any other forms of financial assistance administered by other government bodies (in the case of self-sponsored Public Officers, this includes all types of staff benefits received) for the course, with the exception of SkillsFuture Credit or SkillsFuture Enterprise Credit (SFEC)<sup>3</sup>;
  - vii. Course attendees must not have previously applied for funding for the same course.
  - viii. Course attendees must attain at least 75% attendance for the course, or in the case of an E-learning course, complete all modules.
  - ix. With effect from 1 January 2025, with the exception of conferences and seminars, course attendees must pass the course assessment.
